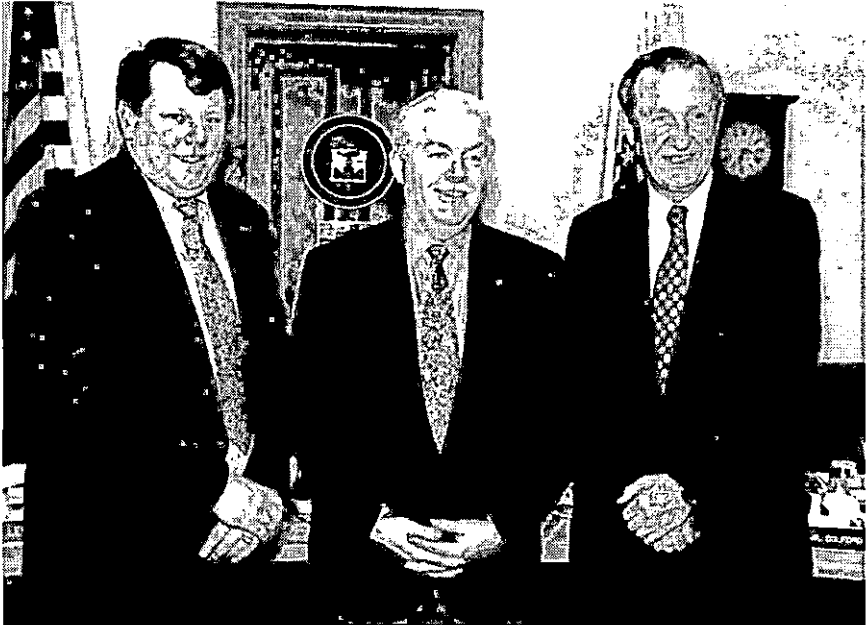

Annual Report of the Selectmen

PRIDE AND PROGRESS IN 1993

The year began with many snow storms which forced the Town to deficit spend in the snow removal accounts in order to keep the streets clean and passible. The Friends of the Bridgewater Library were busy raising monies to support a library expansion. The Friends raised \$1.3 million through private fund raising activities, and the Town voted to support a Bond Exemption in the amount of \$750,000 to pay the remainder of expansion costs.

As Spring arrived, a new alliance was forged between the Town of Bridgewater, Bridgewater State College, and the Southeastern Massachusetts Correctional Facility. This alliance or partnership was the initiative of Dr. Adrian Tinsley with the joint cooperation of Acting Deputy Commissioner Richard Grelotti and the Board of Selectmen. Dr. Tinsley conceived the concept of an Executive Forum as a vehicle for cooperation. The forum evolved into a "Window of Opportunity" for the Town, College and the Prison.



The Town and the Department of Corrections developed a Memorandum of Understanding concerning future expansion plans. This memorandum was the basis of additional legislation filed by Representative Jacqueline Lewis to assist the residents of Alden Square and the Titicut Street area.

The Friends of the Williams Middle/Junior High School renovated the Junior High Auditorium through private fund raising and a substantial donation from Fleet Bank. The unified efforts proved that community cooperation can overcome insurmountable obstacles.

Bridgewater State College donated a new "Jaws of Life" fire rescue apparatus. This new device is used to extricate automobile crash victims through hydraulic pumps and cutting devices. This donation saved the Town over \$17,000 in capital expenses.

The Town of Bridgewater's water distribution system problem became more acute in the Spring. The Board of Selectmen acted and established a Water Study Committee to monitor and recommend action to the Department of Environmental Protection (DEP) in

the monitoring of a water emergency. Much progress was made to resolve the water emergency including rehabilitating all of our well pumps and adding two (2) wells to our well fields. Additional help is needed to correct our very old water distribution system.

The voters of Bridgewater supported an article to construct a new elementary school. This positive vote will ensure that our children's education will get top priority attention in future capital improvements to Bridgewater's infrastructure. Voters also supported an initiative to regionalize grades K-12 with the Town of Raynham. This vote, along with special legislation filed by Senator Marc Pacheco and Representative Jacqueline Lewis, will provide \$4.8 million in additional State aid to the base reimbursement allocation to both Towns.

The escape of two (2) inmates from the MCI on Halloween forced the cancellation of the traditional "Trick or Treat" activities for the children of Bridgewater. A week later, with the assistance of Ursula Garfield and Robin Murray and generous donations of Town businesses; residents and the MCI, the Town rescheduled Halloween in the form of a very successful party.

The Board would like to take this opportunity to thank all Department Heads, Committees/Boards and employees for their hard work, cooperation and commitment to the Town of Bridgewater. A special thanks to Executive Secretary Frank Maher and the Selectmen's Office support staff (Peg Mader, Leigh Norton, Patty Goss and Marie Jennings) for their able and invaluable assistance over the past year.

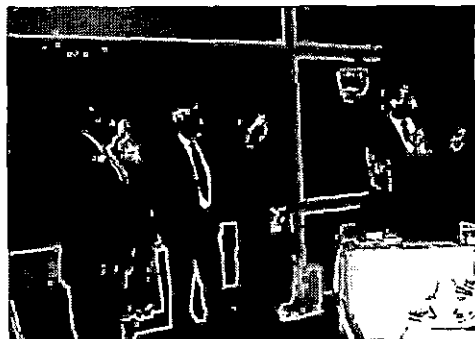

Article 21. A motion was made and duly seconded to Table Article 21 until the Recessed Annual Town Meeting, Wednesday, June 23, 1993. **Voted.**

Article 22. It was voted that the Town create a five (5) member committee to be called TRUSTEES FOR THE SENIOR CENTER AT 10 WALLY KRUEGER WAY; two (2) members appointed by the Board of Selectmen, two (2) members appointed by the Council on Aging; one (1) member appointed by the Senior Building Committee. Each appointment will be for a one (1) year term. The responsibilities of the committee will be to work with the Board of Selectmen to determine the best way to operate the new Senior Center.

TOWN OF BRIDGEWATER WATER BAN BY-LAW

SECTION 1. PURPOSE.

The purpose of this By-Law is to protect, preserve and maintain the public health, safety and welfare whenever there is in force a state of water supply emergency by providing for the enforcement of any duly imposed restrictions, requirements, provisions or conditions imposed by the Town of Bridgewater.

SECTION 2. DEFINITIONS.

For purposes of this By-Law, the following definitions shall apply:

S. ENFORCEMENT AUTHORITY shall mean the Board of Water Commissioners of the Town of Bridgewater who has responsibility for the operation and maintenance of the water supply.

B. STATE OF WATER SUPPLY EMERGENCY shall mean a state of water supply emergency declared by the Department of Environmental Protection pursuant to MGL, c.21G, §15 and MGL, c.111 §160 or by the Governor of the Commonwealth of Massachusetts.

SECTION 3. The following shall apply to all users of water supplies furnished by the Town of Bridgewater. Following notification by the Town of the existence of a state of water supply emergency, no person shall violate any provision, condition, requirement or restriction relating thereto.

Notification of any provision, restriction, requirement or condition with which users of water supplied by the Town are required to comply to abate a situation of water emergency shall be sufficient for purposes of this By-Law if the same is published in a newspaper of general circulation within the Town or by such other notice as is reasonably calculated to reach and inform all users of the Town water supply.

SECTION 4. PENALTY

Any person or entity who violates the provisions of this By-Law shall be liable to the Town in the sum of \$50.00 for the first violation and \$100.00 for each subsequent violation. Fines shall be recovered by complaint before the Brockton Division, District Court Department or by a non-criminal disposition pursuant to MGL, c.40, §21D. Each separate instance of non-compliance shall constitute a separate violation. The fines shall be payable to the Town and credited to water exploration account.

SECTION 5. RIGHT OF ENTRY

Agents of the enforcement authority shall have the right, for purposes of non-criminal disposition procedures, to enter any property for the purpose of inspecting or investigating any purported violation of the By-Law.

TOWN DEPARTMENTS

Police Department

To the Honorable Board of Selectmen and the Citizens of the Town of Bridgewater:

Traffic accidents have had a significant decrease over that of 1992. Burglaries, Larcenies and Auto Thefts have decreased sharply while the remainder of the crime statistics remain about the same.

In June the department was able to purchase two new cruisers from money returned to the town from court fines.

In September, the D.A.R.E. Program (DRUG ABUSE RESISTANCE EDUCATION) made its debut at the Williams Elementary School. Officer Jack Hobson, after attending an 80 hour instructors training course, began teaching "resistance skills" to the sixth grade classes. Funds from the Governors Alliance Against Drugs were used to support the program along with donations from the Bridgewater Savings Bank and Miskinis Buick Pontiac GMC & Isuzu. Without the cooperative effort of the Bridgewater Police Association, the Bridgewater Public School System and the following individuals; George Guasconi, Principal of the Hunt School, Paul O'Brien, Principal of the Williams Elementary School and Robert Blakeley, Superintendent of Schools, this program could not have been possible.

My continued thanks to all the officers, the staff and to the many Town Departments for their continued support.

The Bridgewater Fire Department responded to a total of 3213 incidents: 1428 fire related incidents, 1272 medical incidents and 513 general assistance/inspections/public service incidents.. For informational purposes we responded to 107 incidents at MCI Bridgewater Complex and 225 at Bridgewater State College. These facilities amounted to 12% of our total deployments for Fire and EMS.

Of the fire related runs 29 responses were third alarm responses for structures both residential and commercial. Remaining responses were for inside and outside investigations, motor vehicle accidents, woods fires, medical assists, HAZMAT responses, fires within buildings not classified as structural and miscellaneous unclassified runs. Our highest response area continues to be our Fire District Five, the western quadrant of the Town. The need for a sub-station is again apparent in this sector.

This year personnel were trained and certified in the use of the Defibrillator and the Epinephrine Auto-Injector for allergic emergencies. These, and the institution of Advance Life Support from the South Shore Hospital, have greatly enhanced our EMS capabilities. Training continued throughout the year in HAZMAT to bring all personnel to the required Operation Level as set by State Standards. More funding is needed for training so as to bring the Department to the standards mandated by the Federal and State Government.

Bridgewater State College donated to the Department in November a Hurst Rescue Tool ("Jaws of Life"), we now have two units available for emergencies.

I am requesting that our Forest Fire unit, a 1964 Dodge, be replaced as it now is not cost effective to maintain its operational capability.

My sincerest appreciation to the residents of the Town of Bridgewater, all Boards, Commissions, Committees and Departments for their continued cooperation and assistance.

To the personnel of this Department, a sincere "thank you" for your professionalism and dedication to this Department and our community.

Highway Department

As Acting Superintendent of the Highway Department, I am pleased to present the 1993 Annual Report.

The year 1993 saw the end of an era in leadership at the Highway Department. Superintendent Albert Beninati retired after serving the Town of Bridgewater for 38 years, 17 years of which he served as Highway Superintendent. He began his career in 1955 when he was hired as a call fireman. In 1962, he was hired as an equipment operator for the Highway Department. In 1964, he resigned as call fireman, and from that time on, Al rose steadily through the Highway Department ranks. In 1967, he was promoted to Leadman and Surveyor. In 1971, he was promoted to Foreman. In 1976, he was appointed Highway Superintendent. He remained in the position until his retirement on August 29, 1993. He will be greatly missed. His contributions to the Town are numerous, including the development and refinement of zoning by-laws and sub-division regulations. We wish Al the best and hope to see him continue his interest and activities in Town Government.

The Town of Bridgewater has been experiencing an extremely rapid rate of residential growth. In the past three years, the Town has accepted nearly 40 new streets. An equal number of sub-divisions are under development and will be brought before Town Meeting for acceptance in the near future. It now takes longer for the Highway Department to deliver its services to our residents because of this expanded work load and increased demand. As the Town has grown, the Highway Department has seen a reduction in its work force and in the budget as a percentage of the Town's overall operating budget.

On the brighter side, construction projects for 1993 included chip sealing of Elm Street, Old Pleasant Street, Pine Street, Forest Street, and Cross Street. However, due to budget cuts, we were unable to resurface any streets with local budget monies. The deferred maintenance will be more costly for the Town in the long run.

For State funded Chapter 90 projects, a sidewalk with granite curbing was installed on Pleasant Street from Birch Street to Prospect Street. On South Street, a sidewalk with granite curbing was constructed from South Drive to Forest Street. The roadway was resurfaced from Central Square the full length of South Street to Green Street.

I would like to thank the Board of Selectmen and all other Boards, Departments, Committees and Commissions for their help and cooperation over the past year. I would also like to express my sincere thanks and appreciation to General Foreman Ronald Ladue, Clerk Lorraine Levy, and the entire Highway Department staff for their hard work and dedication.

Forestry Department

As Superintendent of the Forestry Department, I am pleased to present the 1993 Annual Report to the Honorable Board of Selectmen and Citizens of Bridgewater.

1993 was another productive year for our tree planting and replacement program. We obtained a MASS Releaf grant for \$3,060 from the Department of Environmental Management. At the Academy Building, we planted five Armstrong Red Maple trees and three Green Vase Zelkova trees. These trees are replacements for diseased trees that were removed. The Maples were planted along the South Street side of the building. The Zelkovas have a similar upright branching pattern to the Elm trees that formerly lined the streets of Bridgewater, prior to Dutch Elm disease.

The Bridgewater Improvement Association again contributed generously to the Town for tree plantings and roadside beautification projects. This year's project was to give away Flowering Crabapple trees to residents of Broad Street. The trees were planted in front yards so that they are visible to the traveling public. The Forestry Department distributed the trees and assisted some residents with plantings.

Other Forestry Department tree planting projects included distribution of tree seedlings to local residents and replacement of roadside trees that we removed because of disease.

Mosquitoes again were not a severe problem in 1993 as it was another dry year. We have limited funding for roadside spraying, but we cannot provide the level of service by aerial spraying that residents have previously enjoyed.

The Forestry Department continued to assist local residents with tree problems providing advice whenever it was requested.

I wish to thank the Board of Selectmen and all Town Departments who have supported and assisted us this year as well as the dedicated Forestry staff. I look forward to the challenges of the coming year.

Water Department

The Bridgewater Water Department has undergone a major water exploration program and well rehabilitation program to provide the Town with its heavy water demand requirements.

The water exploration program was successful in helping locate possible, future well sites in the Beech Street, Plymouth Street, Vernon Street areas and also to add two new satellite wells at the High Street well field.

The well rehabilitation program will consist of acid cleaning of the wells and overhauling or replacing the motors to bring these wells up to their fullest capacity.

The Town has been mandated by the Department of Environmental Protection (DEP) to go to a corrosion control program. This program consists of adding the chemical, potassium hydroxide, to the water in an effort to neutralize the pH of the water which is slightly acidic. This program has caused some discoloration problems with the residents. This is all part of the process and the Water Department is doing all it can to correct this problem.

The Department also had a leak detection program which covered over 100 miles of the Town's water mains. There were 15 water leaks detected and repaired. This was a savings of a fairly significant amount of water which was being lost. The Town has since purchased leak detection equipment and will run their own program on a yearly basis.

The Water Department's service crew had a very busy year as 12 new fire hydrants were installed, 15 fire hydrants were repaired or raised and 6 fire hydrants had to be moved due to road resurfacing or sidewalk resurfacing.

The Department installed 20 new water services. They also repaired 21 water services that were worn and leaking. There were 1- water service renewals, 9 old water services that had to be reamed out at the corporation connection on the water main. The crew also repaired 4 broken water mains.

There were 147 new water services approved by the Department. The Meter Division, along with reading two times per year, installed a total of 327 water meters and installed over 400 new shut off valves in old houses.

I would like to commend all the personnel in the Department for the great job they have done this past year.

Sewer Department

The Sewer Department this year had no operational problems at our wastewater treatment plant. Our plant processed 314,588,000 gallons of sewerage with a 97% removal of pollutants. Also in that process we dried 3,251 tons of sludge which after composting resulted in the production of 1,710 cubic yards of compost. The compost was utilized by the Town of Raynham as a daily cover for the landfill.

Our facility operated well above the E.P.A. requirements. The plant also treats septage waste (from cesspools) and this year we treated 3,286,388 gallons with no problems to the system. Our hope is to have a new septage holding tank in operation by mid-year. compost remains an ongoing challenge both with odors and to produce a usable product. The odor problem we hope to reduce by installing an odor control system this January. Hopefully, this will reduce compost odors for our closest neighbors. We are still hoping to make our compost a marketable product by trying to reduce the level of copper in the sludge. This will take some time and more experimentation. Our department this year started a program to reduce the amount of ground water that makes its way into the plant. The infiltration program will take some time and effort but will allow us more capacity at the plant.

During the year we assisted the Taunton River Watershed Alliance by testing monthly samples taken from local points on the river to monitor different parameters that effect the quality of the water. Numerous tours were given to groups and individuals who were interested in the plants operation.

Our hope in the years ahead are to sewer some of the needs areas and head off problems with some of our older sewer lines. I would like to thank our personnel at the plant and office for their total dedication, the Water Department for their continuous street assistance and the Highway Department for being there during emergencies.

Board of Health

To the Citizens of Bridgewater:

1993 was, as usual, a busy year for the Board of Health.

A total of 267 septic system permits, which includes new systems and repairs, were issued by our office. This figure represents the largest number of permits ever issued by the Board of Health in any given year. This new and proposed construction in the Town necessitated a great deal of time and effort be expended by our Agent, Richard Simmons, in overseeing percolation testing and septic system design and construction. Mr. Simmons retired as full time Health Agent in April after five years of dedicated service to the Town of Bridgewater. The newest member to the Board of Health is William Nicolas, who joined our Board following the elections in April. Nancy Koska returned part time as Agent.

Our annual Rabies clinic was held in the spring for both cats and dogs. A total of 321 animals received the rabies vaccine by Dr. Robert Brown. With the risk of rabies expected to rise in the State of Massachusetts, the Board of Health is pleased with the response of our residents who innoculated their pets.

With a severe flue season predicted by the department of Public Health, the Board of Health inoculated 400 residents at our annual flu clinic, and dispenses over 1000 doses of vaccine. Again, as in past years, Dr. George Gagne volunteered his services at our clinic and was assisted by Mrs. Candace Riordan.

A waste oil recovery unit was reestablished by the Board of Health at the Highway Department Barn on Spring Street. This facility is available for residents to utilize for the disposal of waste oil. Yard waste was recycled at the Bridgewater Farm Supply on Plymouth Street. For five consecutive weekends, residents were able to dispose of their leaves at this facility.

Work on the Town Transfer Station is progressing. This fall, the transfer station site on Bedford Street was cleared by recruits from the Department of Corrections Boot Camp in Bridgewater.

The Board of Health would like to thank the various Town Departments and Boards for their assistance during the year with special thanks to the Board of Health secretary Vale Sime for her continued diligence and hard work. We would also like to express our appreciation to the residents of the Town of Bridgewater for their cooperation and support.

Office of Planning & Community Development

To the Honorable Board of Selectmen:

The population of Bridgewater continued to grow in 1993 at an annual rate of 2.5 percent. Meanwhile, subdivision plans for an additional 84 lots and 1.8 miles of roadway were approved. The issues associated with these rapidly changing conditions thus became the focal point of many efforts undertaken this past year.

Among such efforts was the acquisition of working capital for the Town's largest industry. In June, a grant of \$500,000 was received from the Massachusetts Community Capital Fund on behalf of the George E. Keith Company. The funds leveraged private financing to increase the Company's production of Walk-Over and other high quality shoes. The com-

pany previously employed over 200 people. Since June, an additional 54 jobs have been created.

A similar effort involved working with the Bridgewater Partnership. During the year, the Partnership had formally incorporated, submitted for non-profit tax status and had prepared an overall work plan for stimulating economic conditions in the downtown. The strategy includes seeking grants for rehabilitation of the old Bridgewater depot and for creating a downtown revitalization plan.

Planning was also the activity of a committee originally formed this past year to identify improvements to the local water supply system. Current and future demands were initially assessed. This office assisted by updating population projections and drafting potential by-law amendments to allow additional well sites within the Town. Actions have already begun on upgrading the existing system and securing off-site improvements from some new developments. While working on long-term actions affecting the water supply the committee increasingly realized the need to address other issues. The committee has since adopted the updating of the Town's master plan as its main objective for next year.

This office has worked with a number of Town boards and departments on many other projects throughout the year. In closing, I would like to express my appreciation for their cooperation and support.

1993 was a busy year at the Senior Center.

We doubled our Fitness Class, Craftmakers, and Painting Classes. And now offer a "Gift Shop" under the sponsorship of Bridgewater C.A.R.E.S. (friends group).

The Senior Center was a "stop over" for the #1,700 Pan Mass Challenge (Jimmy Fund Raiser). Volunteer Bicyclists on their two day trip from Sturbridge to Provincetown, covering 192 miles. Raising monies for the Dana Farber Cancer Fund.

We introduced a FREE Hearing and Hearing Aid testing check-up program. We offered medical, insurance, health, financial, and legal services, and speakers. Trips and socials for our seniors were well received. Director was able to use town budget and grant monies to supply kitchen equipment for new kitchen, hopefully the new year will find senior lunches at the center.

Our first "Free, Senior Citizen Thanksgiving Day Dinner was offered at the center because several "Food Workers" at MCI voluntarily collected monies among themselves for this very generous and kind community service. They also sponsored our Christmas Party as well. Thanks again to MCI, our floors were washed and polished.

The Senior Center records the greatest number of Dial A Bat/Taxi transportation service in these surrounding towns.

Information and referral services have greatly increased, as well as the number of senior citizens using the Center. Needed volunteer response was excellent.

A state grant made it possible to continue and maintain our Outreach Worker position.

We have witnessed an increase in Home Delivered Meals.

Abuse and neglect is growing among our senior population, due in part to older people refusing to identify their abusers, lack of communication of family members responsible for our elder care.

Cost for proper care is very expensive, and there is much more work to be done in this area.

The Elder Affairs Department maintains statistics and documented records on file.

The monthly newsletter is a strong component and community contact for our older people.

My thanks to our wonderful staff, volunteers, donors, instructors and to the many senior citizens helping to make our senior center a necessary and vital community service.

I am submitting for your consideration the annual report of the Bridgewater Public Schools for calendar year 1993.

During the past calendar year, three significant events occurred that will have a major positive effect on the children of Bridgewater.

In June, the Education Reform Act was passed which resulted in the School Department receiving a large sum of additional money. Three additional classroom teachers were hired which allowed us to reduce the class size in kindergarten and grades three and four. The Home Economics and Industrial Arts programs were restored to the Junior High, and the Art program, which was eliminated in 1980 due to Proposition 2 1/2, was reinstituted at the elementary level. Five part-time aides were hired for grade one classes at the Hunt and Williams Elementary Schools due to high class sizes.

On December 11th, the voters approved a \$14.5 million bond exemption to construct a new 1288 pupil elementary school and to renovate and refurbish the Williams Complex into a grade five through eight Middle School. The School Building Committee and the parents who worked on this project are to be commended for their successful effort.

On December 13th, the residents attending Special Town Meetings in Bridgewater and Raynham voted to expand the Bridgewater-Raynham Regional School District to a pre-K through grade 12 district effective July 1, 1994. As a result of this decision, a large additional amount of money will be available yearly for the education of our children which will enable them to receive educational opportunities that have not been available in recent years.

In addition to these three major events, a number of other positive happenings took place. Among these was the complete renovation of the auditorium as a result of a joint effort by Fleet Bank and the community. There was the cooperation of Bridgewater State College and Bridgewater-Raynham High School in allowing us to use space for our students.

Our October 1st enrollment was 2550, an increase of 114 students from the October 1992 enrollment. The latest enrollment projections predict 62 additional students by October 1, 1994 with continued growth over the next five years.

During the past year, Florence Hennessey and Ethel Korotsky, teachers; Anne Smith, school nurse; Mary Bois, Mary Cowan, and Sandra Thompson of the cafeteria staff; and George Silva and John Willette of the custodial/maintenance staff retired from the system after many years of service. Their contributions will be missed.

I would like to thank the staff, parents, and community members who worked together to make 1993 a positive year for our children.

Superintendent Bridgewater-Raynham Regional School District

To the School Committee of the Bridgewater-Raynham Regional School District.

This report, my fifth as Superintendent, is submitted for your consideration. It was compiled by reviewing the minutes of the School Committee from January to December, 1993. Also reviewed were the annual reports submitted by the administrators and department heads. All reports are available for review in the office of the Superintendent.

Two hundred eighty-nine members of the senior class participated in the June 1993 graduation exercises. Over seventy-three percent of the class continued education beyond high school.

The October 1, 1993 enrollment was 1,360 pupils, down from the previous year's enrollment of 1,377.

The school district was informed in October of 1993 that five members of the senior class had been commended in the 1994 National Merit Scholarship program, and one student, Gregory R. Antine has been named a semi-finalist and under consideration for a finalist position.

In the athletic programs, our girls' basketball, field hockey teams, as well as the boys' basketball team, earned championships in the Old Colony League.

A major education reform initiative, the Education Reform Act of 1993 was signed into law on June 18th 1993. It is hoped that this initiative provides both the vision and resources to ensure educational excellence for all students in the state.

On December 13, 1993, the two towns of Raynham and Bridgewater voted to amend the existing Regional Agreement; thus, expanding the Regional School District to include grades Pre-K through 8. The expanded Bridgewater-Raynham Regional School District becomes effective July 1, 1994.

My sincere thanks are extended to my administrative colleagues, the members of the staff, the student body for their cooperation and assistance, the members of the Bridgewater-Raynham Regional School Committee for the confidence placed in me, and to the citizens of Bridgewater and Raynham for their continued support.

We shall continue our commitment to excellence.

Board of Library Trustees

In 1993 the Trustees continued to show their determination to perform their elected responsibility of giving Bridgewater the dynamic library a growing population expects and needs as the 21st century approaches. Ready with appropriate construction plans for the Library's Access, Expansion and Renovation Project, the Trustees worked tirelessly to raise sufficient funds to complete the project. The cost of the project is estimated at \$2,600,000.

Since the mid-eighties, the Board of Trustees has stressed two necessities of the building program: accessibility for all patrons to the entire Library and ample space to house the collection and technology needed by a modern library. During the early seventies as Library use grew, it became apparent that the lack of a passenger elevator hindered many from making full use of our services. In an effort to respond to pleas from the public for

an elevator, grant applications and budget requests were made. Some memorial gifts were set aside to establish an Elevator Fund. Now, at last we are about to see our plans become reality.

The Library Services and Construction Act Title II Federal grant of \$200,000 has been combined with funds from the debt Exclusion passed by a Town vote for \$750,000, a \$500,000 pledge from a munificent Bridgewater couple, foundation grants, the Friends of the Library, major donations from local businesses, civic organizations and community groups, special events, three Bridgewater High School classes of 1941, 1951 and 1958, former residents and numerous gifts from individuals. As of 31 December 1993 a total of \$1,891,571 had been accumulated towards the funding of this project. Unfortunately, this substantial amount was still less than the estimated cost. The public bidding process by law demands that construction contracts can only be awarded for the funds available.

The absolute need to begin construction in early 1994 and the insufficiency of funds have required the trustees to seek an alternative to the single phase plan. Therefore, the Trustees have voted to complete all renovations, bringing our existing facility up to current building and fire protection codes, and build part of the proposed new wing, leaving a part to be completed when additional funds become available.

The Trustees are pledged to continue their vigorous Capital Campaign to raise the remaining funds. Then the people of Bridgewater will have their enhanced Library. During Construction the Board assures patrons that the excellent staff, under Director Wright's outstanding leadership, will continue to provide efficient service and attempt to minimize inconveniences.

Public Library Director

During 1993, staff at our Reference Desk responded to 9,847 requests for information, nearly a 5% increase over last year. Requests for periodicals through the Boston Public Library's telefax service numbered 2,033 an increase of 40% from 1992. The Reference staff attended an extensive 4-day workshop to sharpen their effectiveness in providing information to the public. This series was sponsored by the Eastern Massachusetts Regional Library System. The Library was invited by the Boston Public Library to participate in a federally funded project called "Identification and Preservation Microfilming for Massachusetts Newspapers." As a result, our Library received a free microfilm copy of the complete run of the "Bridgewater Townsman."

The Technical Services Department added 6,697 items to the Library's collection in 1993. Two additional libraries joined the ABLE automated network during the year, making over 900,000 items available to our Library's users through this system.

A total of 181,493 items were loaned to the public during the year. Of the books and magazines borrowed from the Library, 46% came from our Adult Collection. There was an increase of 11% in the number of items borrowed from our Access Center collection. This collection includes adaptive equipment for individuals with disabilities and the increase in its use provides further evidence for the need to make our facility fully accessible. There was also an 11% increase in the number of items reserved, for a total of 13,630.

A total of 156,813 people entered our building to take advantage of our collection, services and programs in 1993. There were a total of 18,477 people who held library cards with 1,617 of these issued to new borrowers.

State funding for Regional Services was increased during the year giving a much needed boost to our Interlibrary Loan Department which serves 24 public libraries in southeastern Massachusetts. During the year this Department searched 5,804 requests from these libraries.

A total of 186 children's programs were held in 1993. These programs introduced 6,061 children, and the adults who care for them, to the pleasures of children's literature and the wealth of information services available through the Public Library. Included in these programs was a series of three programs entitled "The Puppet Project" made possible through an Arts Lottery Grant and a gift from the Friends of the Library. A total of 551 youngsters participated in the Summer Reading Program "Sail on a Sea of Books," reading a total of 10,444 books over the summer. This represents a 12% increase in books read as part of this program from last year and indicates that many Bridgewater children returned to school in the fall with improved reading skills. In addition to these programs, the Children's Room hosted a total of 124 visits from school classes. These visits are offered to all public and private elementary and preschool programs in Bridgewater.

A Long Range Planning process was begun in early 1993 thanks to a study conducted by students in the Marketing Research class at Bridgewater State College. Under the careful guidance of Professor Sylvia Keyes this study used telephone and in-person interviews to measure the community's awareness of library services and evaluate these services. Telephone interviews were made using a random sampling of residents. The work of long range planning for the library will continue into next year as a committee comprised of library users, Trustees, and staff work to develop a strategy for making the vision for the 21st Century Library a reality.

We are deeply indebted to the capable and dedicated staff as well as the generosity of countless volunteers and supporters who helped to make 1993 such a successful and productive year for the Public Library.

Veterans Services Department

The department began the year 1993 with 29 clients and during that year administered to the needs of 53 veterans and/or their dependents. Those receiving aid represented the following periods; Spanish American War - 1, World War II - 8, Korean - 7, Korean/Vietnam - 1, Vietnam - 35 and Persian Gulf War - 1. Twenty new cases plus four re-entries were added. There were 22 terminations and 2 suspensions. Thirty-five clients received ordinary benefits (monetary assistance), 11 received a combination of medical benefits and ordinary benefits. Two assignments were taken netting the Town a \$1,000.00 return and \$1,000.00 pending. Four clients presently on the rolls have excess income requiring a spend down and, therefore, pay a portion of their medical assistance.

Many veterans and/or their dependents are finding it convenient to visit this office seeking assistance in filing claims against Veterans Affairs Department (Federal) in such matters as compensation/pension, dependency and indemnity compensation, reinstated entitlements, burial benefits and health care.

Federal benefits expenditures amounted to \$1,996,799.00 for Bridgewater which includes compensation/pension, insurance and indemnities plus readjustment and vocational rehabilitation.

Two deaths occurred for which there was insufficient means to defray funeral expenses. A special allowance grant was approved to offset the burial expense

Housing Authority

Another year has passed and it is time to reflect on the accomplishments of the Housing Authority, the many kindnesses afforded the citizens of Hemlock Drive and Heritage Circle and the cooperation to the Housing Authority from all the departments and agencies within the Town.

This first full year in our new building at Heritage Circle has been a positive experience for both tenants and administrative staff. Due to the lack of office space at Hemlock Drive the administrative staff were forced to re-locate to our new building.

A new concept to the Bridgewater Housing Authority and Town of Bridgewater are the congregate units. The goal of congregate housing is to offer an alternative living arrangement other than a conventional apartment. It also provides a setting that assists one in maintaining an independent life-style by providing companionship and allowing for supportive services. Further, it provides a residential option to fill the gap between totally independent and institutional living environments and offsets the social isolation so often experienced by elders. Presently seven of the ten units are leased with anticipation of the remaining three units to be leased within the next few months.

The year 1993 also welcomed a new State Appointee to the Board - Mr. Frederick Watson who replaced our former State Appointee, Russell MaDan. We Thank Mr. MaDan for his years of dedication and sincere efforts in promoting additional housing for the Town of Bridgewater.

The Board, Executive Director and citizens of both projects thank all the many departments for their help - Police, Fire, Highway, Selectmen, Building Inspector, Town Clerk, Board of Health, Visiting Nurse and to the excellent ambulance service who certainly had a very busy year.

Collector and Treasurer

With pleasure I submit my ninth annual report to the Townspeople of Bridgewater. This past year has been filled with many new and interesting challenges.

The tax rate was not set in time for the third quarter tax bill to be mailed; this caused the third and fourth quarter tax bills to both be due on May 1, 1993, thus disrupting the cash flow and requiring extra borrowing to fund the payroll and vendor warrants. However, by skipping a quarter of Real Estate and Personal Property tax billing my Collector's Office staff was given time to catch up on some of the work they had fallen behind on because of the greatly increased work load entailed by quarterly billing. We caught up on the Tax Title advertising which resulted in the Collection of a considerable amount of delinquent taxes as reflected in the following Collector's financial report.

The Collector's Office alone brought in over 13.7 million dollars in receipts. My staff prints all the Real Estate Tax Bills, Personal Property Tax Bills, Motor Vehicle Excise Tax Bills, as well as all related demands and we do not send any of our work outside so there is no extra cost to the Town. I am continuing with my program of streamlining and modernizing the office, with many new procedures being implemented since my taking office in 1985. We are, in this office, adding programs within the Town's computer system, to allow the expansion of a well unified computer system, both hardware and software. However, I could not have done this without the able assistance of Irma Sankunas, Executive Assistant and Assistant Collector as well as the total cooperation of my faithful staff Lorraine Conti and Marjorie Newey.

The Registry of Motor Vehicles' new "Marking System" for non-renewal of license and registration for delinquent excise taxes, parking tickets and abandoned motor vehicles has been extremely successful. Many long time delinquents have been found throughout the State and have paid the Town of Bridgewater what it was owed.

I have kept in close contact with State Treasurer Joe Malone to monitor the State distributions as well as Grant monies due us.

My Assistant Treasurer, Nancy Wolfson, has been an invaluable asset to that office. She has put many of the Treasurer's functions on computer as a means of streamlining that office. My goal is to have all Treasurer's functions fully computerized and tied to the other Town offices for automatic transmission through to the accountant.

I would like to take this opportunity to thank all other Town departments, including the school administration and library whose combined efforts have made our office run more efficiently and effectively.

Solid Waste Action Committee

The Solid Waste Action Committee (S.W.A.C.) formed by Town Meeting vote, was charged with developing a long term solid waste disposal solution for the Town. S.W.A.C. is committed to providing a town-owned transfer station for the dual purpose of handling the town's solid waste (trash) in a cost effective manner and also providing a site for a fully comprehensive recycling program. This year's progress has brought these two goals much closer to a reality.

Previously S.W.A.C. obtained Town Meeting approval to apply for a Transfer Station/Recycling Center site assignment on town-owned land located on the easterly side of Bedford Street.

During the year of 1993 S.W.A.C. has aggressively pursued the Department of Environmental Protection (D.E.P.) regarding the evaluation and acceptance of the eighty-four (84) page application submitted by S.W.A.C. for a site assignment. As of January of 1994 approval of the site assignment will occur.

The State D.P.W. has been consulted several times regarding the proposed curb-cut on Bedford Street and approval of the plan is anticipated in January of 1994 as well.

At the Annual Fall Town Meeting the Board of Health was voted a sum of \$40,000 to begin site preparation for the Transfer Station/Recycling Center and the site was subsequently clear-cut and is awaiting better weather and D.E.P. approval before progressing farther. Planning meetings for the design, construction and operation of the Transfer Station/Recycling Center are on-going at the bi-weekly meetings of S.W.A.C.

Zoning Board of Appeals

The Zoning Board of Appeals respectfully submits this report of its doings for the calendar year of 1993.

During the calendar year of 1993 there were a total of forty-four (44) Appeals, requests for Variances and Special Permits. To process the forty-four (44) Appeals the Zoning Board of Appeals held a total of fifty (50) Public Hearings and in each the Zoning Board of Appeals filed a written opinion setting forth its decisions and the reasons therefore.

The Zoning Board of Appeals made the following decisions: Twenty (20) requests for Variances were granted; seven (7) requests for Variances were denied; three (3) requests

for Variances were withdrawn; seven (7) requests for Special Permits were granted; three (3) requests for Special Permits were denied; and two (2) requests for Special Permits were withdrawn. There was one (1) Appeal from the decision of the Building Inspector which was granted. There was an increase from a total of thirty-two (32) Appeals, requests for Variances and Special Permits to forty-four (44) reflecting the improvement in the economic circumstances during the year.

The Zoning Board of Appeals operates under very strict guidelines specifically set forth in the Zoning Enabling Act, General Laws Chapter 40A. The Zoning Board of Appeals can only exercise those powers which are granted by General Laws Chapter 40A. There seems to be a misunderstanding that the Zoning Board of Appeals may grant a Variance on any matter if the subject matter appears to be desirable. Contrary to the question of desirability on the question of granting or denying a request the legislature, under the provisions of General Laws Chapter 40A, Section 10, has set forth very stringent and mandatory statutory prerequisites. Unless all of the statutory prerequisites have been satisfied the Zoning Board of Appeals cannot grant a variance. The Zoning Board of Appeals has no discretion to grant a variance unless all of the statutory prerequisites have been met.

Recreation Commission

To the Honorable Board of Selectmen and the Citizens of Bridgewater:

In April of 1993, the Recreation Commission voted to maintain its present organization with James Campbell (1998) as Chairman who was re-elected to serve an addition five years. Commissioners Thomas Arrighi (1995), David Cox (1996) and Gina Guasconi (1997) continued to serve for a full year and Charles Simmonds, voted at the previous election to fill the final year of former commissioner Joseph Enos (1994), resigned in December 1993.

As in the past, the Commission continued meeting at the trailer at Legion Field on the first Monday of each month of the year at 7:30 p.m. except on the following evening if the first Monday of the month was a holiday. Additionally, the Commission met on many other evenings of each month in preparation for special functions such as the Sno-Ball Tournament and the hiring of help for the summertime recreation and swimming programs. At the January meeting, it was agreed that the postponed holiday meetings would be held one week later.

Highlights of the year included breaking ground for the new outdoor basketball courts at Legion Field, the acquisition of the Rainbow Ends Playground under its auspices and the news of the vote February 7, 1994 of the Citizens of Bridgewater in favor of bond issuance for a new community golf course on the Chaffee 100 plus acre sight. The Chaffee property was sold to Bridgewater with the restriction that it be covenanted for recreational and conservation purposes only.

The general public is always welcome to attend our open meeting (we held no closed executive meetings in 1993) and we did, indeed, have many of the Bridgewater Citizens, recreational organization leaders and Friends of the Bridgewater Recreation Commission attend our meetings.

Several meetings were held with President Robert Stearns and members of the Bridgewater Little League Baseball Association and the Lazaro Field on the corner of Bedford and Cottage Streets will be lighted to extend playing time into the evening. Meetings with President Angelo D'Emilia and members of the Men's Softball League resulted in much needed and extensive field maintenance of the diamond at Scotland Field. Additionally, concrete was poured for the bleacher areas. With a limited budget for the Commission, it has been greatly rewarding to see sporting organizations such as the Little League Baseball and Adult Men's Softball come forth with their funding and labors of love for their sporting activities.

On the weekend of February 19 and 20, 1993, the 10th Annual Sno-Ball Tournament was held at Scotland Field complex with several teams participating. Proceeds from the weekend went to benefit the Bridgewater Lions Club's "Journey for Sight" charity and additional activities in town.

Each year the task of field assignments to various sports organizations' requests becomes more and more formidable. The limitation of available space and finances in our budget require a difficult juggling act to satisfy all. During 1993, we assigned field usage at Legion and Scotland Fields to Babe Ruth Baseball, Bridgewater Youth Soccer, Bridgewater Little, Adult Men's Softball, Girl's Softball, Bridgewater-Raynham Sports, Bridgewater State College, Shaw's Sunday League, Over Forties Softball and Middle School Sports.

At the close of 1993, the Bridgewater Recreation Commission accepted with regret a leave of absence of our field caretaker, Glen Tufts who is exploring a scouting opportunity with a major league baseball team. We wish to extend to Glen our appreciation for a job well done and best of luck in his new adventure.

At this writing, a notice has been posted for the opening vacated by Glen and the commission will hire a replacement well in advance of the spring opening of the fields.

In closing, the Bridgewater Recreation Commission would like to thank the Board of Selectmen and many other Town officials who have given us valuable assistance throughout the years.

Sunshine Daycare Center provides preschool, daycare, afterschool and toddler play-group programs to children ranging from age 15 months to 9 years.

The Adult Day Health Program, operated by New England Sinai Hospital and Rehabilitation Center, completed their third year at the Conant Center, providing daily care for those with disabilities or illnesses in the greater Bridgewater area. The Center offers skilled nursing, rehabilitation, educational counseling, social and recreational services and meals to participants as well as transportation to and from the Adult Day Health Program.

The Bridgewater Visiting Nurse Association continues to develop and expand as the need for home care services grows in the community. With a great increase in employees since moving to the Center in 1990, the BVNA expanded their office space this year to include an administrative suite within the Conant Building allowing for more clinical staff.

Community health programs and nursing education continue to be the focus of Healthcare Educational Resources. Their services include certification programs in Adult, Infant and Child CPR, First Aid and Tot Lifesaver. Continuing Education Units for Registered Nurses and Licensed Practical Nurses are awarded at many inservices offered throughout the year. Participants in their programs include group and family day care providers, local school personnel and town coaches, boy scout troops and personnel, parents, health care providers and many safety conscious organizations throughout Massachusetts.

REGIONAL RESOURCES

Plymouth County Cooperative Extension

County Extension programs are carried on through Plymouth County in cooperation with the University of Massachusetts and the United States Department of Agriculture. The Cooperative Extension System is supported by County, Federal and State funds, and operates under Federal and State laws and agreements. Education programs focus on water quality, horticulture, agriculture, 4-H youth development, nutrition and food, natural resources, leadership development and family life issues facing the County. Volunteer advisory groups work with staff on developing specific programs. Local citizens, appointed by the County Commissioners, serve as County Extension trustees, directing the overall program. The Extension staff serve as a direct link with the University of Massachusetts. New research findings are translated into practical applications and shared with people and communities through workshops, conferences, field demonstrations, technical assistance, newspaper articles, radio and television. Publications such as regular newsletters and booklets, factsheets, and home study courses, bring information directly to those who need it.

In Plymouth County, the Cooperative Extension outreach office is located on High St. Hanson. In Southeastern Massachusetts regional programs are conducted in cooperation with the Barnstable County Cooperative Extension Program. Satellite offices of UMASS Cooperative Extension are located in Bristol and Norfolk Counties. UMASS Cooperative Extension also operates the Cranberry Experiment Research Station, located in Wareham. The Cooperative Extension office (Hanson) is open 8:30-4:30 PM Mon-Fri. Currently the County field staff consists of a County Director, two 4-H Youth Development Specialists, a Nutrition/Family Life Educator, and a Landscape/Nursery Specialist. A federally funded Expanded Food and Nutrition Education Program, which has been active in Plymouth County since 1969, is run under the auspices of Cooperative Extension. Currently, one supervisor, and three outreach educators work in this program conducting a UMASS nutrition education certificate course. As your representative to the Old Colony Planning Council, I am pleased to present this report on behalf of the Council for 1993.

The Old Colony Planning Council is established by state statute as the Regional Planning Agency for fifteen communities in the greater Brockton-Plymouth areas and is authorized to prepare plans for the physical, social and economic development of the District, as the designated Regional Planning Agency, the Council serves as a clearinghouse for federal and state grant program applications, a data and information center, a component in the environmental review process, and reviews applications for state financial assis-

tance loan programs. In additions, the Council is the Metropolitan Planning Organization for transportation planning; is designated as an Economic Development District by the U.S. Department of Commerce, Economic Development Administration; and, is the Area Agency for Aging for the planning and administration of Elder Services for a twenty-three community area of Southeastern Massachusetts.

Each municipality is represented on the Council by one delegate and one alternate delegate member. The Council members establish policy, develop the work program, employ the professional staff and determine the activities of the Council to be carried out by the staff. the Council meets on the last Wednesday of each month at 8:00 p.m. in the Council offices located at 70 School Street, Brockton, MA.

In 1993 the Old Colony Planning Council completed a series of forums on the topic of Regionalism which were presented in response to an increased interest in intermunicipal cooperation by local officials and driven by the difficult financial conditions at the local community level. The Council was supported in this effort by the Martin Institute of Stonehill College and other state, regional and county organizations. There is a high level of interest in the ways that local governmental services might be delivered more efficiently and less costly through various means and these are being and will be continued to be pursued through the Council's efforts.

Self Help Incorporated

Self Help, Inc., is greater Brockton's and Attleboro's antipoverty agency dedicated to improving the quality of life of limited income individuals and families, and making all segments of the community responsive to the needs of the limited income, disadvantaged and minority populations.

During the program year ending September 30, 1993, Self Help received a total funding of approximately \$9M and provided direct services to 44,268 limited income households in the area.

In the town of BRIDGEWATER, 892 households received direct services totaling \$211,581 during the program year 1993.

The total funding of \$9,087,092 does not tell the real value of human services delivered to the area as a whole. Self Help's funding enabled us to mobilize an additional \$2,509,530 of other community resources such as, contributions from the towns, volunteers, and private donations. The gross value of Self Help during the past program year was \$11,596,622.

Self Help currently employs 215 individuals, many of whom are of limited income and minorities.

We feel that the year October 1, 1992 through September 30, 1993 was a successful one for us and very helpful to our limited income population. We thank the many volunteers, Boards of Selectmen and their representative to our Board of Directors, FREDERICK WATSON, III for helping to make our year a success.

Bridgewater Visiting Nurse Association

To the Honorable Board of Selectmen:

Home Health Care is perhaps one of the fastest growing industries today. One only has to pick up a newspaper to become aware of the ever expanding health field. With the closing of mental institutions, mergers of large hospitals, and increasing medical services, we are finding more and more people released from hospitals before they are fully recovered.

Once, where a staff of one nurse was able to care for all our residents, we now have a staff of fifty-two, including home health aides, skilled nurses, therapists and recently a psychiatric nurse. As Bridgewater residents' needs present themselves, we at the Bridgewater Visiting Nurse Association have tried to meet them by expanding our services.

To further fulfill our commitment to prevention and health care, the Bridgewater Visiting Nurse Association schedules several health clinics and health conferences throughout the year. Lead screening, TB testing and blood pressure screening are included in the services rendered this past year. In April 1994, we will hold our twelfth Annual Health and Fitness Fair. All residents in the Town of Bridgewater are invited to join us at the Conant Community Health Center and have their blood pressure, cholesterol and blood sugar tested. Very often these simple tests aid in early detection of health and medical problems. This year we also offered an Alzheimers' Support Group for care providers of those suffering from Alzheimers and Dementia.

With the financial support of the Town of Bridgewater, donations to the Friends of the Bridgewater Visiting Nurse Association, contributions from local businesses, the Old Colony United Way and the Conant Trust Fund, we have been able to continue expanding our services to meet the ever growing needs of the residents of Bridgewater.

I would like to extend to each of you who contribute time, energy and money in support of the Bridgewater Visiting Nurse Association, our sincerest appreciation.

Plymouth County Rape Crisis Center

The Plymouth County Rape Crisis Center provides direct services to sexual assault survivors and their significant others. These direct services take the form of hotline counseling via our 24-hour hotline system, individual and/or group counseling, and medical and legal advocacy. In addition to these direct services, Plymouth County Rape Crisis Center provides rape awareness/prevention seminars to school aged children, professional agencies, religious organizations and other community groups.

Last year, the Plymouth County Rape Crisis Center received 74 hotline calls from residents of Bridgewater. Nine residents and her significant others received ongoing individual and/or group counseling. 341 individuals from the town of Bridgewater received rape awareness/prevention education also, Plymouth County Rape Crisis Center provided a ten hour sensitivity training to students and staff at Bridgewater State College, and we participated on a panel which assisted approximately 300 school nurses in identifying and intervening in child abuse (sexual and physical). This seminar was also offered at Bridgewater State College.

As always, we thank the Town of Bridgewater for its continued support, and we look forward to working together with you in the upcoming year.
